Resolution No. <u>2011-3</u> of the Highway District No. 1, New Plymouth, Idaho, adopting Sub-Districts for the purpose of determining each highway commissioner's district for elections (Idaho Code 40-1704).

Highway District No. 1

Sub-Districts description

The Highway District is divided into three (3) sub-districts. The district boundaries were designed to contain nearly equal road mileage. Roads that run along sub-district boundaries are assigned to one of the sub-districts.

Sub-District Boundary descriptions:

Sub-District #1:

All of that portion of Highway District #1 that is West of Elmore Road.

Boundary Roads: Elmore Road is considered to be in Sub-District #1.

Total miles: 39.07 – number of addresses: 3,403

Sub-District #2:

All of Highway District #1 lying East of Elmore Road and North of the following described line:

Beginning at the intersection of SW 2nd Ave and Elmore Rd.

Then run East to the intersection of SW 2nd Ave and Butte Rd.

Then run North to the intersection of Butte Rd and Highway 30.

Then run East along Highway 30, then Idaho St, then along the Center Section line for Section 2, T7NR4W to the Payette River (also the Highway District Boundary).

Boundary Roads: The segment of SW 2nd Ave that forms the boundary is considered part of Sub-District #2.

Total miles: 35.87 – number of addresses: 742

Sub-District #3:

All of Highway District #1 lying East of Elmore Road and South of the following described line:

Beginning at the intersection of SW 2nd Ave and Elmore Rd.

Then run East to the intersection of SW 2nd Ave and Butte Rd.

Then run North to the intersection of Butte Rd and Highway 30.

Then run East along Highway 30, then Idaho St, then along the Center Section line for Section 2, T7NR4W to the Payette River (also the Highway District Boundary).

Boundary Roads: The segments of Butte Road, Highway 30 and Idaho St. that form the boundary are considered part of Sub-District #3

Total miles: 39.24 - number of addresses: 1,555
